Parent/Guardian Responsibility, Waiver & Release

- It is the parent's or legal guardian's responsibility to notify the teacher of any limitations due to disability, illness or injury.

RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OR RISK, AND INDEMNITY AGREEMENT
